Since the beginning of the year, the following have occurred that have severely impacted the operating dollars of PYBC. • Insurance -PYBC based on a recent audit is underinsured by 50%. • Landscaping -change in landscaping company with an increased cost of approximately \$40K. • Seawall -Belaire seawall repair related to recent information for the city has determined we are responsible for 100 feet of this wall. Also seawall near Whittier Towers (related to quiet title) • Truck -purchase of a new maintenance truck • Chipper -purchase of a new chipper • Street lighting - new low voltage street lighting • Digging of a new well (bids are being obtained) • Sewer project • Club house pergola, and floor tile	
1650	Insurance report Stacey Tynion	PYBC has had an increase in premium for 2023-2024 of 54%. In addition the wind policy will come due in October and this cost is not yet known. Of note: several companies will no longer write policies for the barrier islands and the homes in PYBC have had significant increase in value.	
1655	Seawall report Jim Ramburgh	Lauderdale by the Sea deputy town manager informed Jim they identify PYBC as the owner of a portion of the seawall (57 feet) since we are paying taxes on a portion of the area needing replacement and it was included in the
